I had the opportunity to attend the 2016 NRA Annual Meeting in Louisville, KY a few weeks ago; it was great to see over 82,000 like-minded pro Second Amendment supporters in one location. The meeting was a brisk reminder of the 2016 political environment and consistent challenges from politicians attacking our rights as gun owners. The battle never ends. The recent tragic terrorist events in Orlando have only intensified the gun control debate. As mentioned in the previous newsletter, please go out and vote in 2016! It is anticipated the next President of the US will select three new Supreme Court justices.



South Dakota Governor signs into law changes for the SD Concealed Carry Permit. The "Gold Card" was created to bypass the need for a NICS background check when purchasing a firearm in SD. ND concealed carry holders have enjoyed this freedom for years. Starting Jan 1, 2017, The SD Gold Card concealed carry permit will become available and is expected to gain ATF approval to negate a firearms purchase required background check.

Thanks to the DTGCA leadership and membership in helping support this bill in the SD Legislature, SD will now become the 27<sup>th</sup> state to have a provision for NICS exempt background checks for firearms purchases. Currently, 10% of all FBI NICS background checks in SD are "delayed", which makes for a real challenge at the DTGCA Gun shows to learn five days later that the background check is approved.

President Larry Jones recognized a quorum present and called the meeting to order.

Minutes of February 7, 2015 were read and approved. Second quarter report of 2015 was presented and reviewed. Paul Herman moved to accept the Second guarter report with Daethal Docktor's second, all ayes, carried. Cliff Wasfaret moved to approve the tax audit of Gidding's & Associates with Laura Ennen's second, all ayes, motion carried. Daethal Docktor moved with Kelly Lorge's second approving the Executive Secretary to incorporate Quick Books to the bookkeeping system for the association. Cost will arrange between \$750 to \$1000 for training and the program. Old business was opened by President Larry Jones with discussion on the events that transpired this last show season. New business brought the discussion on directing the show managers to enforce the Show Rules of Conduct.

Daethal Docktor moved with Kelly Lorge's second to add to the Show Rules of Conduct – DTGCA recognizes a "Zero Tolerance" to any Discharge of a fire arm, accidental or otherwise. To be bulleted under this 1)Show manager has authority to determine who is at fault. 2) If fault lies with table vendor, vendor is ejected indefinitely from all association shows. 3) If fault lies with the table vendor, the vendor has a right to appeal to the

Kelly Lorge moved with Daethal Docktor's second to add to the Show Rules of Conduct - Re wording of Letter F on the Show Rules on Conduct - All firearms including air guns must be strapped, re strapped and or made inoperable, all ayes, motion carried.

Daethal Docktor moved with Cliff Wasfaret's second to propose a change to the By-Laws on the Board of Directors Articles. The proposal will be prepared for presentation to membership at the Annual Meeting in February 2016. Show of hands vote 5 yes, 3 opposed, motion carried.

Paul Herman moved with Daethal Docktor's second to raise the Base Pay for the show managers to \$750.00, all

Cliff Wasfaret moved with Don Glynn's second to donate \$10,000.00 to the South Dakota "Concealed Carry Negates Back Ground Check", all ayes, carried.

Kelly Lorge moved with Laura Ennen's second to donate \$15,000.00 to the NRA/ILA, all ayes, carried. Laura Ennen moved with Daethal Dockter's second for Kelly Lorge to coordinate the design and ordering of the 2016 belt buckle. 100 buckles are to be ordered, all ayes, carried.

A \$1000.00 bonus was approved by the Board of Directors for the Executive Secretary for 2015.



# The Art of Collecting

#### **SERIES II: HOW TO DISPLAY**

Of the 14 shows sponsored by the DTGCA, 10 shows offer display tables to be judged. Eligibility for competition of a display table is as simple as contacting the show manager or signing up your display at the show. What is not so simple are the display competition rules and regulations that must be followed to ensure your display is eligible. Let's review.

#### **EDUCATIONAL FACTORS**

All displays must have a TITLE OR THEME

Is the title accurate and pertinent to the display

Are the individual items being displayed related to each other and the theme

Are there catalogs, pictures, accessories or other items to further the purpose of the display

Each item in the display should have an educational appeal to the viewer. Item (s) should be identified by labels or some other means so viewer can learn from and understand what they see.

Can the novice and advanced collector alike learn from the display

#### **COLLECTOR IMPORTANCE**

Rarity or survival rate. Are the item (s) displayed rare, or are they seen at every show? Rare means a degree of scarcity. For example: A one of a kind item is very rare, but a serial number (I) is only one item in series. It is not rare.

Is there documentation to support the historical importance of the item (s)

Are there Special Features of the item (s) displayed, i.e. engraving, coloration, wood quality, available accessories,

Condition of the display varies from "As New" to "Used in the field". If restored, quality of the restoration or completeness of the item (s) will be reviewed.

#### **DISPLAY METHOD**

Does the display show uniqueness with good use of artifacts, material and space which will be evident in the creativity of the display?

Appearance should be original in design or the original factory design.

All identification should show specialties or specifics.

#### APPEAL TO THE VIEWER

Is the overall appearance of the display appealing to the eye and an attention grabber? Is the Value of your display known – Historical, Functional, and Artistic? Is the display surround captured in the display appearance?
