President's Message #7.....

As I write this, the first gun show of our season, the fall Sioux Falls show, is underway. Hopefully, you, our members, have endured the long dry spell since our last gun show in April and are ready to begin a new season of camaraderie, searching for the perfect gun for your hunting or shooting needs, looking for something to fill a hole in your collection, or selling something you no longer need. On the other hand, if you are in the gun business, are ready to spend weekends plying your trade. Although the economic crunch is still upon us, guns appear to be selling well, at least according to statistics. This summer I have participated as a buyer at some national auctions. High quality Colt and Smith & Wesson guns continue to bring top dollar, with a few exceptions. Some of the Single Action Army guns as well as some of the high end Winchester and Marlin guns did not appear to bring as much money as one would expect. In fact, at one of the auctions, several pieces were passed because the bidding was insufficient. The most recent auction was a lesson in history with numerous palm pistols, cane guns, and Volcanic pistols, including one with a shoulder stock. The quality and ingenuity of the era gone by is absolutely amazing considering the lack of a lot of machinery, CNC and robotic manufacturing.

The DTGCA Board of Directors took up several items at its summer meeting. The most pressing item was finding someone to take on the management of the Mitchell show. My message in the last newsletter made mention that we had no applicants as of the end of May. When the dust finally settled, we had two fine applicants that were interviewed by the Board. The Board hired Bob Campbell of Sisseton, SD to manage the Mitchell show. Many of you know Bob from the fine Winchesters, including an engraved Henry that he has exhibited at our shows. Bob ran a show in Minnesota, where he lived, for many years. As always, the Board minutes are published with the newsletter, so you, the membership can find out what else is going on.

The other issue at the Board meeting, which generated member input, was the issue of people coming in to the shows on Friday to buy. At the meeting, the Board decided to continue its policy of not allowing people in early. In fact, security at some shows will be beefed up to insure that this policy is kept. This policy is in keeping with a vast majority of the input we received from our membership. Another item of interest to many is the issue of what merchandise is appropriate for DTGCA shows. Some of it needs to be cleaned up, particularly at the two Sioux Falls winter shows. Coins, knick-knacks, toys, pottery, artwork, lamps and other such items do not belong at those shows. If you are a vendor, please do not place them on your tables at either the Sioux Falls Trophy or Sioux Falls Collectors Classic shows. This will spare you the embarrassment of having the show manager or their security asking you to remove them. The DTGCA Board is committed to making the Sioux Falls Trophy Show more of a regional powerhouse than it is already, and it takes the cooperation of everyone to do so. The Collectors Classic show is for weapons that cannot be purchased in the everyday gun shop. This means that modern, readily available weapons are not allowed, nor are non-gun related things such as coins, knick-knacks, and the like. Please keep in mind that this is Board policy and not just me giving my opinion. The Board adopted a vendor agreement form for use with the Collector Classic show. Perhaps we need to consider it for the Trophy Show as well. ---And yes, that last sentence was nothing more than my opinion. Speaking of Board policies governing shows, a listing of those policies can be found elsewhere in this newsletter. Since it is that time of year again, the ATF rules governing gun shows is included in this newsletter to remind people of how they need to conduct business at a DTGCA gun show.

Bill Braun moved to donate \$1000.00 to the **Whetstone Sportsmen Club Youth**, Hal Lee seconded, all ayes, carried.

President Kent Miller ordered the Directors meeting to reconvene directly after the Show Managers meeting; for it now being 4:00 the Show Managers entered meeting.

President Kent Miller brought the meeting to order at 4:45 p.m. continuing the New Business. Correspondence of responses to newsletter article were reviewed and discussed. The future of Mandan, ND's show venue was discussed.

U.S. Department of Justice
Bureau of Alcohol, Tobacco, Firearms and Explosives

Important Notice to Dealers and Other Participants at this Gun Show



This NOTICE applies to activities permitted at bona fide gun shows, as defined in Title 27 of the Code of Federal Regulations, Section 478.100. Federal firearms licensees ("FFLs" or "Dealers") may only sell firearms at gun shows within the State in which their licensed premises is located.

DEALERS LICENSED IN THIS STATE

- MUST display license.
- MUST comply with all recordkeeping requirements of ATF regulations concerning acquisitions and dispositions of firearms, including the recording of the place of sale.
- MAY dispose of handguns to residents of this State only, provided that the purchaser is at least 21 years of age and all provisions of the Brady law are met.
- MAY dispose of longguns to residents of any State, provided that the purchaser is at least 18 years of age, the laws of both States are complied with, and all provisions of the Brady law are met.
- MAY dispose of firearms to any FFL.
- MAY acquire firearms from any FFL licensed in the State and from any non-licensed individual.
- MAY take orders of any firearm from a non-licensee and ship the same to a licensee in the purchaser's State of residence from whom the purchaser can then take possession after the provisions of the Brady law are met.

DEALERS NOT LICENSED IN THIS STATE

- MUST display license.
- MUST comply with all ATF recordkeeping requirements concerning the acquisition of firearms.
- MAY acquire firearms from any FFL licensed in this State and from any non-licensed individual.
- MAY make a sale and deliver curio or relic firearms to any other FFL licensed in any State as long as the laws of both States are complied with.
- MAY ship curio or relic firearms from this show to any other FFL.
- MAY display and take orders.

NON-LICENSED RESIDENTS OF THIS STATE

- MAY acquire longguns or handguns from FFLs licensed in this State, provided all provisions of the Brady law are met.
- MAY dispose of personal firearms to any FFL.
- MAY acquire from and dispose of personal firearms to non-licensed residents of the State. However, non-licensed individuals may not be engaged in the business of dealing in firearms without a Federal firearms license.
- CANNOT acquire from or dispose of firearms to non-licensed residents of any other State.
- CANNOT ship in interstate commerce, except to themselves or an FFL, a firearm that has otherwise been lawfully acquired; must, when shipping to themselves, declare the firearm to the commercial or contract carrier.

NON-LICENSED RESIDENTS FROM ANOTHER STATE

- MAY dispose of firearms to any FFL.
- MAY acquire longguns only from FFLs licensed in the State, provided the laws of both States are complied with and all provisions of the Brady law are met.
- MAY order firearms from any FFL and have them shipped from the show to an FFL in their State of residence by a commercial or contract carrier in accordance with State and Federal law.
- CANNOT acquire handguns.
- CANNOT acquire from or dispose of firearms to non-licensed individuals.

**DAKOTA TERRITORY GUN COLLECTORS ASSOCIATION (DTGCA)
COLLECTOR CLASSIC SHOW RULES**

General:

The Collector Classic show is DTGCA's show for Collectable Firearms and Related items. Displays are encouraged. Items for sale need to meet the criteria for being collectable.

1. DTGCA reserves the right to remove any item or items deemed objectionable. Refusal to comply may result in expulsion.
2. All transactions involving the purchase, sale, trade of firearms and other items must comply with all applicable State, Federal and or Local Laws.
3. Tables will be provided, table covers are mandatory on them.
4. Tables not occupied by 10:00 a.m. on Saturday will be resold.
5. Tables vacated prior to the show's posted closing time will revert to DTGCA.
6. All Display and Exhibit tables will be maintained till the posted Sunday closing time and kept uncovered when the show is open to the public. Failure to follow the rules may result in the moving of your table's location or expulsion from the show. If there are extenuating circumstances please contact the show manager.
7. No portion of a display table may contain items for sale or trade.
8. Smoking is permitted only in designated areas.

Safety:

1. DTGCA will conscientiously ENFORCE Safety Rules and all decisions will be final.
2. ALL Firearms must be UNLOADED.
3. ALL firearms will be tied to make them inoperable with nylon ties, this includes modern, antique and muzzle loaders. Failure to comply may result in expulsion or removal of the item(s) from the show premises at the discretion of the show manager. Firearms in enclosed display cases that are not readily accessible to the general public are exempt.
4. DTGCA reserves the right to inspect all incoming and outgoing items for safety and or theft.

Permitted items examples of:

In order to maintain a quality show DTGCA or the show manager may appoint a quality control committee whose decision will be final. All items on trade tables must be considered collectable by the show manager or DTGCA's committee.

1. Collectable small arms which comply with all Federal, State and Local Laws. This will include commemorative firearms and miniatures.
2. Collectable Ammunition for small arms.
3. Collectable Reloading paraphernalia.
4. Collectable accessories and attachments for small arms.
5. Parts for Collectable small arms.
6. Antique edged weapons, antique Armor, Bows, Crossbows and other antique weapons of a collectable nature.
7. Collectable Flags, Uniforms and parts thereof.
8. Collectable Native North American artifacts, which are original and authentic. Including, original authentic antique American Indian jewelry.
9. Western Frontier paraphernalia made for use on the Western Frontier. But not general antiques.
10. Western Art which is defined as original and authentic both graphic and sculpted.
11. Books and literature related to all allowed items including photos.
12. Any other articles or devices that can be properly related to the activities of the DTGCA.

Non Permitted Items examples:

1. Illegal firearms, machine guns, silencers, and other class 3 weapons, except those of a pre approved display.
2. Fully automatic or semi-automatic look a likes, including AK-47's, Mac 10's, M 16's, UZI's or anything else that resembles the current popular definition of an Assault weapon.
3. New or used weapons of current manufacture, except for commemoratives.
4. Modern mass produced firearms or accessories, which would not be considered collectable even if out of production.
5. Jewelry, except for authentic original collectable antique American Indian Jewelry.
6. Art, except for Western Art as defined above.
7. Items barred by safety rules.
8. Any item(s) deemed inappropriate by the show manager and or DTGCA committee.
9. General antiques.

If not COLLECTABLE or if you can buy it at the average sporting goods store, don't bring it. IT WON'T BE ALLOWED.

I have read the above DTGCA Show Rules and agree to abide by them.

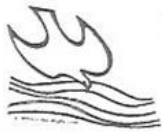

POLICIES ADOPTED BY THE BOARD OF DIRECTORS
SHOW MANAGER POLICIES

July 14, 2007 with amendments included, Revised 7-19-08

1. **FREE ADMITTANCE** - Members continue to gain free admittance to the show when they show their current membership card.
2. **DISPLAY TABLES** - Free Display tables have been discontinued as mandatory, however stipulated Show Managers have the discretion to give free tables as prizes for the displays.
3. **EXPIRATION DATE** - Membership cards have one common expiration date, January 1 of every year.
4. **NO SHOW LIST** - Notice is given the No Show list is active and to be followed.
5. **WOODEN NICKELS** - Notice is given wooden nickels distributed in previous years providing free entry to DTGCA shows are still to be honored.
6. **ATF FORM** - Notice is given there is a new ATF Form effective in year 2007. A copy of this form is enclosed and copies of this form are to be distributed to all table renters by Show Managers at all forthcoming shows.
7. **SOUTH DAKOTA TAX** - Notice is given there appears to be changes in the State of South Dakota tax interpretation as applies to DTGCA. Upon verification in writing, this information will be disseminated at a later date.
8. **TROPHY SHOW ADVERTISING** - Mandated by Board action the Board of Directors take on the national advertising of the Sioux Falls Trophy Show and the cost will be billed back to the Sioux Falls Trophy Show and be included on the Show Report submitted to the Association.
9. **GATE ADMISSION** - ALL shows \$5.00
10. **WATERTOWN BANQUET** - Discontinued
11. **MANAGERS' FEE FOR RENTED TABLES** - Mandated by Board action that Show Managers fee for rented tables be increased by \$1.00 for shows with rented tables 2000 LF or under. Amended 1-05-08
12. **MANAGERS' BASE PAY** - Mandated manager's base pay raised to \$550.00 (from \$400.00) starting September 1, 2008. 1-05-08
13. **SHOW REPORT NO MEALS** - Mandated by Board action no meals are to be expensed out and submitted on Show Report to DTGCA.
14. **SHOW REPORT RECORD KEEPING** - Mandated by Board action Renewals and Record keeping are the show manager's responsibility and there should not be a charge for them on the Show Report.
15. **SHOW REPORT CO MANAGER** - Mandated by Board action there be one paid Show Manager per show listed on the Show Report and no co-manager.
16. **SHOW REPORT NO PHONE CHARGES** - Mandated by Board action no expense for phones is to be taken and submitted on the Show Report. If this causes an extra load on a Show Manager a submitted copy of the phone bill can be presented to the Board for consideration of reimbursement.
17. **SHOW REPORT MILEAGE/FUEL** - Mandated by Board action submitting mileage is disallowed but stipulated a Show Managers travel allowance of \$75.00 is mandated if the show they manage is over a 30 mile radius of the managers "residence".

WINCHESTER MODEL 1900 EXPERIMENTAL .22 PISTOL

Owner/Author Dean & Sandy's Gun Shop Enderlin, ND



A variety of SS pistols using Winchester Rifle Actions were made between 1900 and 1922. They were made 1900, 1902 and 1904 models. The design of these pistols varied in rapid taper, pencil and heavy barrels. Grips were made of walnut, brass and pot metal. Trigger guards were made of metal straps, such as this one, molded brass along with the frame and some of wood carved along with the grip and forearm. Not even sight configurations will be the same. Some have serial numbers and some do not. This gun has a W3 on bottom of receiver, not sure if it would be the serial # or inspectors mark. There is some

information on these guns on page 279 of the George Madis handbook.

At the Mitchell Gun Show a fellow came to me and asked if Winchester really did make these. I told him I guessed so. He came back and measured everything on the gun. The next day he came back and told me he dug his gun out and everything measured the same as this one. He thought his dad cut off a rifle and made the pistol. This now hangs in his gun cabinet to show off. Never know what Winchester did.

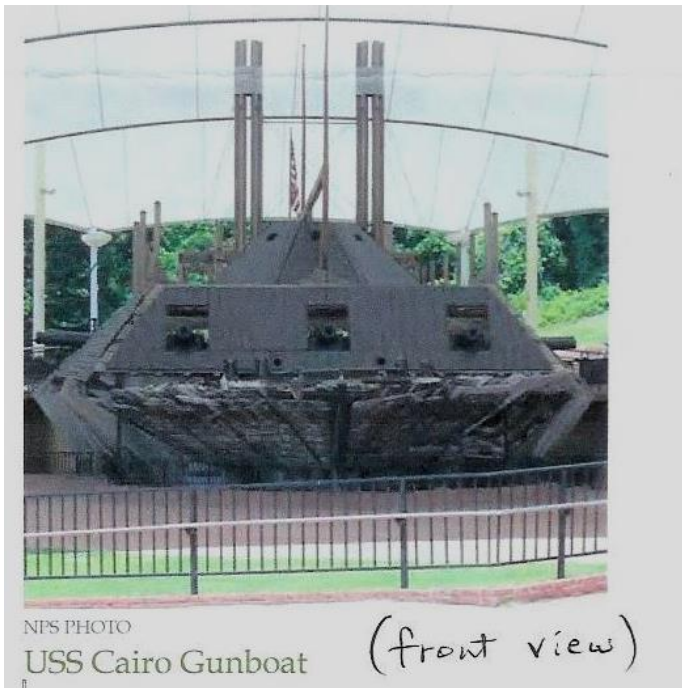
FOR THE LOVE OF HIS STATE

The great state of Mississippi, with all of its historical heritage which includes the Vicksburg National Military Park, home of the U.S.S. Cairo. As you will recall there was a short article in the last newsletter and this piece will elaborate on and end the segment.

The great gunboat itself is huge, and is remarkably well-preserved. It's hard to believe it was underwater for 100 years. It is set up next to the museum that has all its artifacts on display, and there is a gigantic tent-type canopy well above the ship (about 2/3 the size of a football field) to keep the elements and fierce Mississippi sun from it. There are catwalks all over and above the ship (which is in dry dock for visitor use) and all of her original cannons, armor, boiler & pipes, stern wheel & entire propulsion system are in place. It's a very massive and impressive display.

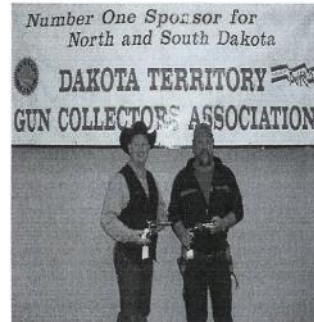

In 2009 over \$24,000 was awarded to the Black Hills area in the form of NRA Foundation Grants including the Pennington County 4H Shooting Sports Program and Spearfish Rifle and Pistol Club. A total of over \$104,000.00 in grants has been awarded in the Black Hills area.
