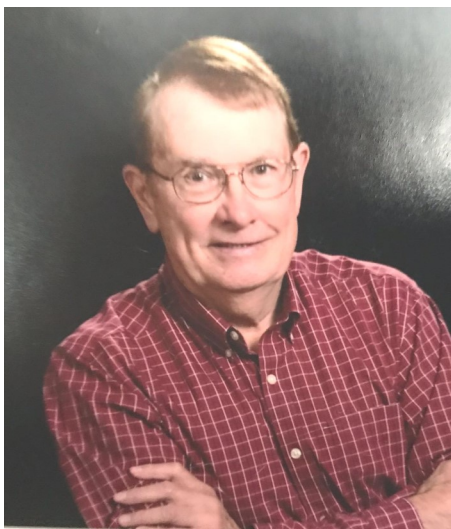

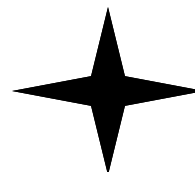

February 1, 2020 Annual Meeting

The Annual Meeting of the DTGCA was held Saturday, February 1, 2020 at the Dakota Event Center, Aberdeen, SD directly following the close of the show for the day. Present were President Tom Seaburg, Executive Secretary Vicki Morin, Directors Daethal Dockter, Laura Ennen, Rick Drennen, Don Glynn, Dale Flihs, Wayne Duncan, Bob Lee and Kelly Lorge. Director absent was Brandon Maddox.. There were a total of 45 in attendance. President Tom Seaburg established a Quorum was present and opened the meeting for business.

The Executive Secretary Vicki Morin read the minutes from 2-2-2019 and presented the 2019 Annual Report to membership. Paul Dulitz moved with Dale Flihs's second to approve the minutes and the 2019 Annual Report as presented, all ayes, motion carried.

Old Business was opened with an update on the Fargo Show by President Tom Seaburg.

Bill Bobby was recognized and addressed the Show Awards. A show of hands showed 25 Yes to 20 Nay to have the show awards reinstated to whatever gun show wanted to handle them at the discretion of the show manager. Award value presented will be at the discretion of the show manager as well, plaque, paper certificate, \$'s.

At this time the seating of the new president took place. Tom Seaburg moved down to Past President for 2 years, Daethal Dockter moved to his new position as President of the DTGCA for 2 years.

President Daethal Dockter opened the election for officers with paper ballot voting.

For North Dakota's vice president position Wayne Duncan/Bob Campbell nominated Bill Braun, thrice call for nomination, Steve Livermore/Jim Keller moved nominations cease, all ayes, **Bill Braun Vice President for North Dakota**. For the At Large position Bob Lee/Wally Darkow nominated Wayne Duncan; Kelly Lorge/Dale Flihs nominated Bryan Ennen, thrice call for nominations, Bob Lee/Cory Zimmerman moved nominations cease, all ayes, **Wayne Duncan retained his position as Director At Large**.

For the South Dakota position Bob Lee/Rob Moore nominated Keith Hakeman; thrice call for nominations, Steve Livermore/Al Hanson moved nominations cease, all ayes, **Keith Hakeman as a South Dakota Director**. For the 2 North Dakota Directors Kelly Lorge/Dale Flihs nominated Don Glynn; Bob Lee/Dale Flihs nominated Adam Sandvig; Ken Retzlaff/Jim Keller nominated Laura Ennen; Wally Darkow/Dale Flihs nominated Bryan Ennen; Wally Darkow/Bob Campbell moved nominations cease, all ayes, **Adam Sandvig and Laura Ennen North Dakota Directors**.

New Business was introduced. Wally Darkow was recognized to voice comments on the Watford City show. Executive Secretary was directed to secure the future dates with the Rough Rider Center in Watford City, ND. There are 3 candidates for the show manager position for the Watford City Show; Larry Weninger (asst. 2019 show manager), Al Hanson, show manager of the Minot, ND show, Kirby & Michele Voegele of Watford City. Bob Lee moved with Wayne Duncan's second to invite candidates to the Summer Meeting of 2020 for an interview, all ayes, motion carried.

Paul Dulitz was recognized to address the membership card no free entry action, discussion.

Paul Dulitz moved for adjournment with Wally Darkow's second, all ayes, motion carried, meeting adjourned at 6:50 p.m.

Guests from the Friends of NRA (Doug DeLaRoi, field rep) were recognized to give their presentation and request for funding for the Friends of the NRA. 18 banquets, Gun of the Year Henry 45-70 with a cost of \$881.00 each banquet totaling \$15858.00. All action was tabled until the Summer Meeting held in August of 2020.

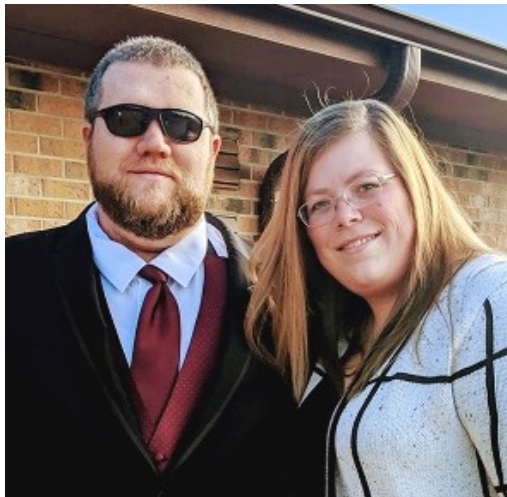
