DAKOTA TERRITORY GUN COLLECTORS ASSOCIATION, INC. SERVICE ANIMAL POLICY

The Dakota Territory Gun Collectors Association, Inc. ("DTGCA") is committed to providing full and equal enjoyment of its goods, services, facilities, and accommodations to individuals with disabilities. As part of that commitment, the DTGCA welcomes service animals to its events to the extent required and permitted by applicable law, including the Americans with Disabilities Act of 1990, as amended.

Service animals include dogs that are trained to do work or perform tasks for the benefit of individuals with disabilities, including physical, sensory, psychiatric, intellectual, and other mental disabilities. Other species of animals, untrained dogs, and pets are <u>not</u> service animals and may be excluded from DTGCA events.

Service animals <u>must</u> be housebroken (i.e. bathroom trained) and under the control of their handlers <u>at all times</u>. Service animals also <u>must</u> wear harnesses, leashes or other tethers unless doing so would interfere with the service animal's performance, in which case the handler must use other methods for control (e.g., voice control, signals, etc.). **Service animals that fail to comply with these requirements will be asked to leave.**

Parts I & II – Introductory history and handguns, By Brian Carlson (DTGCA Life member)

This series is based on the display that I have exhibited over the last few years, in whole and in part,

at several DTGCA shows

Part I - History

Before 1917, Finland had not existed as an independent country.

Throughout time, it was

fought over by Sweden and Russia. The former controlled the ter-

ritory primarily from the middle ages

until 1809, although its influence - especially along the western coast - remains strong to this day. In 1809, Sweden ceded control of the territory to the Russian Empire, becoming the semi-autonomous Grand Duchy of Finland. During this era of Russian control, authoritative control over the region ebbed and flowed with the particular Tsar reining in Russia. Beginning in 1898, Tsar Nicolas II's appointed governor over the Grand Duchy instituted a policy of eradicating a separate Finnish identity in the region. This led to a subsequent rise in Finnish nationalism, which came to fruition upon the fall of the Tsar in the 1917 Russian revolution. As a result, Finland declared its independence on December 6, 1917, but was immediately embroiled into a brutal civil war in early 1918 between Communist backed Red Guards and anti-Communist White Guards. By mid-1918, the White Guards had essentially won control of the country, and with the League of Nations recognizing Finland as an independent country after the end of World War I in 1918, its political and economic security began to stabilize (figure 1).

By the late 1930's, the Soviet Union, emboldened by the non-aggression pact with Nazi Germany, began occupying the Baltic states of Estonia, Latvia, and Lithuania. Since Leningrad (St. Petersburg) was less than 50 Kilometers from the Finnish border, the Stalin made hard-headed demands for control of Finnish owned territory, both on the mainland and to control Finnish islands in the Baltic Sea. Finland refused to acquiesce, so on November 30, 1939 the USSR bombed Helsinki and 600,000 Soviet troops crossed the Finnish-Russian border, starting the Winter War. The brunt of the Winter War was fought primarily along the southern border of Finland – with the Soviets massing their forces on the Karelian Isthmus and around Lake Ladoga - although Soviet invasion forces had breached essentially the entire Finnish border from the Baltic to Arctic seas. However, they were repelled by the skillful and dedicated Finnish forces who were generally better led and vastly more motivated than the Soviets. While the Soviets had tanks and vastly more artillery, their Generals ranged from "yes men" to incompetent, due to Stalin's various purges throughout the 1930's. The Finns better knowledge of the turf they were defending, with the brunt of their soldiers being from rural areas and subsequently more attuned to using firearms, plus being better trained to fight in the winter, made up for the lack of artillery and no tanks. Let alone the psychology of their homeland being invaded. As such, they were able to hold back the invaders. Helping the Finns was Mother Nature, as the winter of 1939-40 was colder than average, with most battles taking place in sub-zero weather (-40 degrees, the same in Fahrenheit and Celsius, was common). As the war progressed, the masses of Soviet troops being replenished to the front (generally by a factor of forty to one) meant that the Finns couldn't hold the back indefinitely. As such, a negotiated peace led to a ceasefire on March 13, 1940. As part of the agreement, Finland ceded 16,000 square miles of territory to the Soviets, mostly the Karelian Isthmus and Finland's only Barents Sea port city of Petsamo; the Soviets essentially getting most of what they wanted.

During the Winter War, Finland began aligning its self with Nazi Germany, as they essentially followed a "my enemy's enemy is my friend" approach to foreign policy. After Germany stated Operation Barbarossa (the invasion of the USSR) in early 1942, Finland went on the offensive to invade and reclaim the lands lost at the end of the Winter War on June 22, 1942, starting the Continuation War. While the Germans provided some limited materials assistance and some SS foreign legions (more to recruit the scrappy Finlanders for Germany than to fight with Finland), the Finns were essentially on their own. To placate Stalin, Great Brittan declared war against Finland shortly after, but aside from one token air raid, they did nothing else to aid the Soviets. While the United States and the Soviet Union were technically allies, the US never declared war against Finland. Indeed, sizable numbers of expatriate Finns from the US fought for Finland as foreign volunteers in the Winter War. The Finns eventually re-occupied the territory they lost in 1940 but did not invade across the pre-1939 Soviet border. Yet, as in the Winter War, by mid-1944 the same basic formula was playing out; while the Finns had the drive, they lacked the materials and massive manpower of the Soviet Union. As such, the Soviet-Finnish armistice was signed on September 19, 1944, ending the Continuation War. Once again, the Finns re-lost the same territory (figure 2), but also severed ties with Nazi Germany (to include forcibly driving out the German troops remaining in the northern regions of the county) and were also required to disband the Finnish Civil Guard. Yet there was still one thing that, despite two wars within a decade and the subsequent years since, the Soviets were not able to take - Finland's freedom.

General notes on Finnish military equipment markings.

Before 1942, the Finnish armed forces sporadically marked their arms and material. The Civil Guard, on the other hand, marked all their arms and accoutrements with "SY" since inception. Early in 1942, the Finnish Army started marking all material that belonged to them, after going through their logistical branch, with "PUOLUSTUSLAITOS" (GOVERNMENT PROPERTY). Most often, this was with a roll stamp, which on hardened firearms components didn't mark well. By mid-1942, it was changed to a simpler stamp of "SA" within a rounded corner rectangular box (SA meaning "Suomi Armeija" – Finland Army). From that point on, all weapons and ancillary components – new, existing, and confiscated – were thusly marked (figure 3). If Civil Guard arms were transferred to the Army, they had the "SA" markings added, but generally the "SY" markings were untouched. This labeling was officially used until 1970, when the Finnish armed forces went to a castle turret pictogram stamp, which is still in use.

Part II - handguns

Finland originally had a smattering of various handguns – ranging mostly from police issued Fabrique National model 1900's to Russian Nagant revolvers left by the Russians after the 1917 revolution. Finland's first attempt at a standardized pistol was the purchase from France in 1919 of 10,000 Spanish made "Ruby" series autoloaders, called the M/19. These hand-made pistols from a multitude of small factories with no real interchangeable parts (usually including the magazines) were a logistics nightmare, and were chambered in the anemic 7.65 x 17mm (.32 ACP) to boot. In 1922, Finland's started fixing the error of the M/19 "Ruby" by an initial purchase of 2,000 model 1908 Lugers from DWM of Germany, as the M/23, chambered in .30 Luger (Germany was

forbidden by the Treaty of Versailles to make handguns in 9mm Parabellum at that time). In short order, the Finn's initially were not impressed with the lackadaisical stopping power of the .30 Luger cartridge (especially since it barely penetrated heavy winter clothing), so they also purchased a small

quantity of 9mm Parabellum P/08 Lugers in the late 1920's, the Finns denoting them as the M/08. During the Continuation War the majority of M/23's were rechambered for 9mm Parabellum by installing Sako and Tikkakoski (Tikka) made 100- and 120-mm barrels and appropriate recoil springs, essentially becoming a M/08. In total, the Finish armed forces purchased approximately 8,000 Lugers from 1922 to 1929 (figures 4 and 5).

While the 9mm placated the Finns for a potent enough round, they were becoming less enamored with the actual pistol due to its less than stellar operation in extremely cold weather - on top of desiring a locally produced weapon. Enter Finnish arms designer Aimo Lahti. By 1929, he developed the first prototypes for what became the L-35 Lahti pistol. While it had a passing resemblance to the Luger, they are significantly different in operation. Namely, the toggle mechanism of the Luger was jettisoned for a blowback mechanism with a Blish-like lock and a slide accelerator to work in cold weather. The Lahti was adopted in 1935 and production started in 1938. All were produced by VKT (Valtion Kivääritehdas = State Rifle Factory), which was renamed Valmet after the end of the Continuation War - with 5,731 Lahti's delivered to the Finish military (figure 6). VKT also licensed Lahti production to Husqvarna of Sweden, starting in 1940, as the M/40. The Swede's found themselves between a rock and a hard place by 1940, as they had initially adopted the Walther HP, buying 1,500 in early 1939 (becoming the P-38 when adopted as the primary sidearm of the Third Reich), but received very few as Germany was putting as many as they could make to use annexing its neighbors and then invading them. With both the essential loss of their primary military handgun vendor – let alone one that could possibly invade them – Sweden looked to its neighbor Finland. With Finland having bigger troubles with their neighbor to the east, they didn't have the capacity to sell the Swedes pistols, but where happy to license L-35 Lahti production to the Swedes (made by Husqvarna as the M/40) after the Winter War ceasefire. As such, none of the Swedish M/40's were used by Finland, even during the Continuation War (figure 7). Finland also purchased handguns from other countries. Immediately before the winter war, primarily from Fabrique National of Belgium. Most notable was the M35 High Power from Fabrique National. While Finland had evaluated the High Power before the Winter War, the start of hostilities forced them to purchase the pistols expediently. They bought a total of 2,400 High Powers from FN, complete with shoulder stock holsters, delivered in two separate shipments in December 1939 and March 1940 (figures 8, 9, 10). In similar quantities (2,500 each) Finland also purchased from FN before the fall of Belgium the model 1910 and model 1922 self-loading pistols, in 7.62 x 17mm/.32 ACP (figure 11). Most of these were used in rear echelon units, yet some m/1922's saw front-line service.

Both before the Winter War and during The Continuation War, Finland also obtained approximately 4,100 Beretta model 1935 (7.62 x 17mm/.32 ACP) in 1941 and 1,400 to 1,500 model 1934 pistols (in 9mm Short/.380 ACP) from Italy.

Swedish expeditionary forces in the Winter War also brought their FN and Husqvarna made M/1907 self-loading pistols, chambered in 9 x 20mm/9mm Long (figure 12). 860 were left behind by them at the end of the Winter War, which were issued to some front line troops during the Continuation War, but generally in the northern (Lapland) battlefields, due to the non-standard to

Finland chambering.

SHOW RULES OF CONDUCT

- A. Exhibits, displays, buys, sells and trades all types of acceptable arms and their accessories, along with the Association membership and guest attendance, formulates the primary goal of this Association Show Meeting.
- B. Illegal arms and bulk explosives shall not be brought in the Show Meeting Hall.
- C. Only the contracted table surface or surfaces shall be the display areas. Exception can be made by show manager.
- D. No playing videos or electronic audio visual aids.
- E. An item that is considered detrimental, by the opinion of the majority Board members present, to the safety or best interest of this Association shall be barred. No loaded or strapped to oneself firearm except for authorized security personnel.
- F. All firearms including air guns must be strapped, re strapped and or made inoperable.
- G. DTGCA recognizes a "Zero Tolerance" to any Discharge of a fire arm, accidental or otherwise.
 - Show manager has authority to determine who is at fault.
 - If fault lies with table vendor, vendor is ejected indefinitely from all association shows.
 - If fault lies with the table vendor, the vendor has a right to appeal to the Board of Directors.
- H. Badges will be distributed by the show manager to all authorized attendance and security at the beginning of set up for the show.
- I. Contracted space shall be well maintained by its renter from garbage and refuse.
- J. If a show is sold out, all "no show tables" will be open until 10:00 a.m. Saturday morning, then allocated via a waiting list in numerical order.

- Ammunition
- Smokeless Powder
 - o Only in factory sealed containers
 - o No Larger than 8 pound containers
- Archery Equipment
- Bayonets
- Cartridges and Shot Shells for Collectors
- Gun Parts, Sights, Gun Repair Supplies
- Pole Arms & Battle Axes
- Military Uniforms and directly associated accourrements related solely to conflicts in which the United States was involved. Said items are to be individually displayed or sold in bulk or from clother racks.
- American Cowboy, Indian Weapons & Personal Artifacts (Antique Only)
- Armor

- Books and Videos (Weapons related)
- · Firearms of all legal types
- Firearm Curiosa
- Knives, Swords & Daggers
- Military weapons & direct weapons related items
- Powder Flasks & Horns
- Paintings, Pictures, Prints & Statuary-covering items on this list (Jewelry not permitted)
- Reloading Tools and Supplies
- Belt Buckles Dealing with item on this list only
- Scrimshaw-Dealing with items on this list only.
- Bumper stickers are prohibited from all gun shows.
 - An exception: stickers may be sold or given away by non-profit organizations whose purpose is to promote shooting or gun ownership: stickers must be shooting or firearm related.

Prohibited Items:

- Smoke bombs
- Blow guns
- Black Powder
- Communication equipment
- No dummy ammunition in firearms
- Martial Arts items (Ninja), examples: throwing stars, numb chucks, throwing balls, etc.
- Parts, Kits, manuals, instruction books, etc. for the conversion of legal items to illegal items, or making of bombs, silencers, machine guns, etc.
- Any form of media on government overthrow or anarchy, including anti-semidry or bigotry items.
- All items prohibited by the organization rules shall be banned from the show and must be removed from the facility.
