### Message from your Executive Secretary -

As many of you know these last 6 months in the Association have been pretty stressful and full of a lot of questions. The Board of Directors have tried so hard to keep the core values of this organization together while still moving ahead into the 21st century. They have done an amazing job but have faced some pretty tough hurdles this year. From the Audit to the constant emails from members wanting information.

As some of you know it has been extremely hard on me mentally and physically to be your Executive Secretary these last 6 months. I have been harassed, had rumors spread about me, had my name slandered, been called names, been accused of crimes that I didn't commit all because, someone couldn't wait for the results of the Audit, to the point where it was so bad that I needed someone to sit with me at your Shows because of the con-

stant badgering. Asking questions in one thing but some people take it to far.

Many of you will see that I got a raise in the meeting minutes that I have posted in this newsletter. At the Annual Meeting and then again at the Special Meeting in June I was accused of hiding information about Shows. Let's set the record straight. If a show lands in November like the Sioux Falls Fall Show did last year. The Show Manager has 60 days to submit all of his / hers bills and receipts to the Executive Secretary's Office. So, with that being said and as I have tried to explain my self before and just got berated. The Show was in November, 60 days later would be January. Which would be a new year. So, that show will show up on this years Executive Secretary's Report. I am not hiding information from you, nor is the Board of Directors. To believe that narrative, is just naïve.

The Meeting Minutes have been a year behind always in the newsletter because the Board of Directors only meet 2 times a year and the General Membership only meet once a year. Because of this the meeting minutes do not get approved very quickly. But at the Summer Meeting the Board of Directors have decided to start approving the minutes faster so you can start seeing them in a more timely fashion. Again, we are not hiding anything from you. This is how it was done long before I took over.

I know that there are many more things that I have been accused of. But these are the main ones that I wanted to address as your Executive Secretary. So, with that being said at the Summer Meeting on July 19th, 2025, I gave the Board of Directors my resignation. Not because of the Audit, I know that I have done nothing wrong. I did the job that Vicki trained me to do. I put in my resignation because of the members who cheered and clapped at the Special Meeting when a member got up and asked for the Board of Directors and the Executive Secretary resignation. Dakota Territory Gun Collectors Association (the Association) engaged our firm to audit the cash basis financial statements of Dakota Territory Gun Collectors Association (the Association) for the years ended December 31, 2018, 2019, 2020, 2021, 2022, 2023, and 2024.

We were provided paper copies of the Association's records from 2017 through 2024. The documents provided included the annual IRS Forms 990 and compiled financial statements for several of the years under audit. We were also provided with gun show reports and some supporting documentation for cash receipts and disbursements for the years under audit. In addition, we obtained a backup copy of the Association's QuickBooks file, which we used to generate reports and review documentation of transactions.

Through our review of the information provided and discussions with the Board of Directors, we noted the following:

- The Organization has significant cash reserves.
- The Association did not have access to all of the bank statements as gun show managers maintained their own bank accounts. The Association has worked to consolidate bank accounts, but we suggest further consolidation to one savings account and one checking account.
- Gun show reports, while detailing receipts and uses of cash for each show, did not have sufficient documentation such as invoices for payments made that are needed in order for us to determine whether activities were properly recorded.
- Documentation for the period under audit did not detail whether bills were paid by the Board Secretary or from cash at each event.
- Documentation from many of the gun shows included handwritten notes of expenses and revenue sources with little to no support.
- More complete information was available for 2023 and 2024 as documentation had improved, but not all documentation, including bank statements and activity for gun show bank accounts, was available for these two years.

We met with the Board to discuss these matters and to suggest improvements to internal control processes in order to allow the Association's financial statements to be audited in the future. Some of our recommendations include:

- Simplify gun show reports completed by show managers
- Continue to have a Board member and the show manager count cash and sign off on show reports
- Use checks for payments to vendors instead of cash
- Require Board-level reviews of transactions

The Board has been very receptive to the suggestions and is working to revise and improve processes.

We have determined that performing an audit in accordance with our professional standards is impossible due to the lack of sufficient documentation and incomplete accounting records. Due to the cash nature of the business, any further review of the available records would likely not reveal any instances of malfeasance and would result in the Association incurring unnecessary additional expenses.
